The Digital India Week 2022 with the theme '*Catalyzing New India's Techade*' kicked off on **4th July** at **Gandhinagar, Gujarat**. The July 4th to 9th weeklong event commemorated the path-breaking journey of the flagship initiative of the Digital India Programme that was inaugurated by **Prime Minister Sh. Narendra Modi**. The event came in the backdrop of India

emerging as the 3rd largest ecosystem for startups globally. Backed by the strong tailwinds created under the umbrella of the Digital India programme and successive campaigns, India has more than 73000 startups and 100+ unicorns.



About Digital India Programme

The Digital India Programme was launched on **July 1, 2015** by the Hon'ble Prime Minister of India with a vision to transform the country into a digitally empowered society and knowledge economy.

Today India boasts of the world's 3rd highest number of Startups with new unicorns sprouting almost every week. During the pandemic, Digital India has played a significant role in the nation's resilient response. Digital technologies have enabled the Government to reach the remote parts of the country at the click of a button.

To celebrate the success of 7 years of Digital India, the first week of July was chosen and participants from all over the country were invited to show their contribution to make India a provider of Digital Services to the World.

Digital Initiatives/ Footprints the Department of Legal Affairs

LIMBS - One of the most important initiatives is the Legal Information Management and Briefing System (**LIMBS**), an innovative web-based application software tool which utilizes standard templates, monitors the court cases in a proactive, transparent and effective manner. It is a dashboard based system, where user departments can see their legal matters at a glance. LIMBS ensures proper e-governance, as visualized by the government. **Sh. Rajiv Mani (Additional Secretary) Department of Legal Affairs** is the Nodal authority of the LIMBS portal who is playing a key role in the implementation, coordination and training of the LIMBS portal in all Government Ministries/Departments.

NOAP - The Notary Online Application Portal (**NOAP**) being the next software tool which has made the application process extremely user friendly. Now applicants can sit at home or be anywhere and apply online. The application process has become simpler and has led to saving of huge amounts of paper and money for the applicants. This is another example of Public centric justice delivery initiative.

The department has also started using the **e-office** and **digitized all litigation records of active cases** in a time-bound manner. This has helped in making the process for virtual hearings of government litigation cases more efficient. This is a significant step towards achieving the goal of a “Digital India”.

About Participation of the Department of Legal Affairs

The Department of Legal Affairs, Ministry of Law & Justice, was nominated to show their projects which contributed to the Digital India Programme, namely **NOAP** (*Notary Online Application Portal*) and **LIMBS** (*Legal Information Management & Briefing System*) and also to showcase the Department’s initiatives to go Digital, improve justice delivery and to make it more citizen centric, a team of officers of the Department was chosen, led by **Dr. Anju Rathi Rana (Additional Secretary)** and **Ms. Haimanti Bhattacharya (Director)**.

The Department of Legal Affairs nominated members from the LIMBS Team and NOAP Team namely, **Shri Himanshu Saraswat (Sr. Programmer)**, **Ms. Sadhvi Sishodia (Sr. Software Developer)** and **Shri Rahul Kumar (Sr. Software Developer)** to participate in the Digital India Week 2022 and to showcase the digital initiatives that have been undertaken for enhancing e-Gov and digital solutions, from **02nd to 07th July, 2022** at Mahatma Mandir, Gandhinagar, Gujarat.
