




INTRODUCTION OF ADVOCATE MODULE

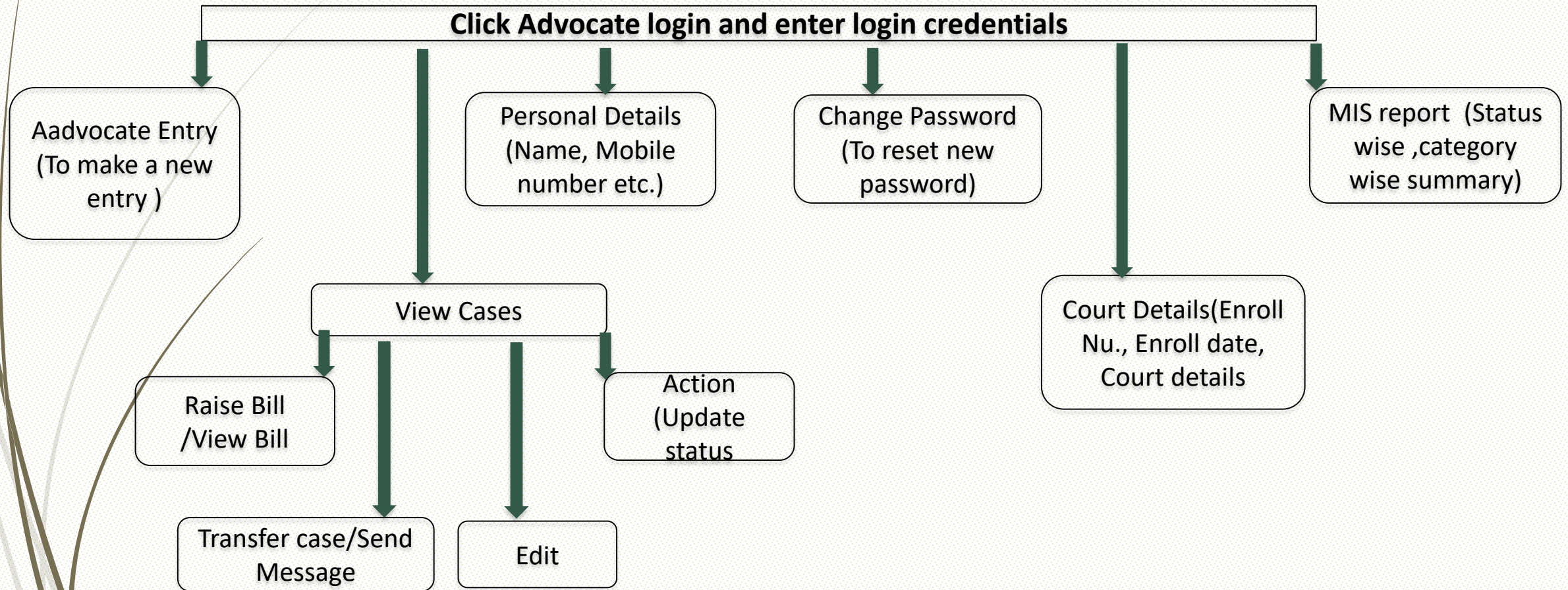
- An interface has been developed in LIMBS portal of the Department of Legal Affairs to facilitate Panel Counsel. Advocate are important stake holders in LIMBS application
- Advocate Module is an extended module of LIMBS for active participation/Interaction of panel advocates vis-à-vis court cases.
- LIMBS site generate username and password for each advocate based on captured advocate details. Once the advocates log into advocate module details of ministry wise cases assigned to them are populated.



BENEFITS OF ADVOCATE MODULE

- Aims to digitalize the process of Advocate's bill. Advocate can raise their bills online in a more transparent way for timely payment.
 - Branch secretariat and Ministries are getting soft copy of advocate bills against entered cases on LIMBS
 - Total **454** online bill raised by **56** Advocates of different Ministries and Branch secretariat
