1. Background of LIMBS: LIMBS is a simple and innovative web base application which utilizes standard template with well-defined fields for storage, categorization and search of legal cases and documents, managing timely administrative procedures and audit trail which in turn bring uniformity in office standard norms of entire chain of UOI litigation.

The Legal Information Management and Briefing System (LIMBS) is a web-based application for monitoring of all court caseswhere Union of India is one of the parties. LIMBS came into existence for allministries/departments/autonomous organizations/CPSUs in 2016, and advance version in **January 2020** since then the application is seamlessly working under the supervision of department of Legal Affairs, Ministry of Law and Justice (as Nodal Ministry). It is an innovative and easy to access online tool which is available 24x7 to all the stakeholders' viz., government officials, department users, nodal officers, higher officials of ministries, advocates, arbitrators and claimants of Ministries to upload the latest information.

It is a dashboard-based system for the user Ministries/Departments on which they can see their legal matters at a glance. This version is overhauled with the use of Open-Source technologies using Coordinator framework of PHP to enhance the security of the system and improve the efficiency of the system.

Enter full name: It accepts only alphabets and space. Number and special charactersare not allowed:

- Mobile Number: Enter 10-digit mobile numbers.
- Designation: Select designation from drop down list.

- Department/Attached/Subordinate Office: Select department/attached/subordinate office from the drop list. Subsequently select sub-department and functional department (if available) from the dropdown list.
- Username: Length is between 5 to 15, It accepts alphanumeric values
- Password: Password should be at least 8 characters long (It should contain at least one number, one alphabet and one special character.At least one upper case and one lowercase letter should be there)
- Add User: Click on the ADD USER button to complete the registration process.
- Contact Nodal/local/LIMBS Team for activation

# 3. Role of Ministries Nodal officer / Local admin

Nodal Officers and Local Admins (sub-nodal officers) can activate newly registered users of concerned Ministry/ Departments/Autonomous organizations/ CPSEs, etc. Nodal Officer can only make Local Admins/Sub-Nodal Officers. They can change the profile of users (their name, mobile no., etc.) who have retired or transferred and can also delete wrongly entered or duplicate cases. Under the tab "Users", he can activate new users by using the scroll down option "Enable". Also, on the right side of tab "User", there is a tab "Deleted Users". Clicking on this tab will give the list of deleted users.

## 4. Process of Court case entry

**1. My court cases:** This is the user domain where users enter and update the status of existing cases via new entry and compliance entry

## 1.1 New Case Entry

Clicking it, which will open a new form in which user can enter details of a new case. Say, for example, in the case of **High Court and Distt. /Session**, after user has uploaded information about the 'Court details, BENCH,' Case No./Case Year' and 'Case Type', a Case Number Record (CNR) will be generated. After generation of CNR Number, when user clicks on tab 'GET INFO', the remaining columns of this form will be automatically filled up from the e-Courts database. [A CNR number is allotted for High Court and District Court cases only. After saving the details in 'New Entry' of a case, a LIMBS no. is generated]

for example, in the case of Hon'ble Supreme Court after entering diary number, when user clicks on tab 'GET INFO', the remaining columns of this form will be automatically filled up from the e-Courts database. Rest of the information filled by the user manually.

- vi.Details This is used to view the one-page summary of the case.
- vii.Add Progress This is used to add internal remarks and input.
- viii.Link Tag Matters This is used for linking of two different cases.
- **ix.Add More Advocate** This is used to add more advocates details.

Update Case status via CNR

- 3. Transfer of Cases This module relates to transfer of cases from one user to another. When a user has been transferred from one department to another, LIMBS portal has the facility to transfer the cases in the account of transferee to the new officer/user. The cases which are wrongly transferred there is a provision to pull back those transferred cases if the existing user hasn't accepted it. There is an option to transfer even 20 cases in one go. For this, user will click on the tab "Transfer of Cases" which has the following provision for the users-
  - •Transfer of Case within/outside Ministry.
  - Request for transfer of cases

In each case, a window will pop-up seeking certain details which would be filled up by the user. Thereafter, user will select the case(s) to be transferred and click on the "Transfer" button given at the end of list of cases and the case(s) will be transferred.
